

Nomination Process.

Please find attached a nomination form for the election of the officers and board of WGUK 2025. Each nomination must be supported by a 2025 member organisation and be agreed by the Nominee. Each WGUK organisation can only nominate one person.

These forms must be returned to Alan Thompson, MPAUK Chair, by Friday 21st March at which time a list of nominees will be circulated to member organisations giving details of the election process which will take place at the WGUK Championships on Saturday 5th April.

Full details of the voting procedure will be issued when we advise who has been nominated but please remember that each member organisation will have one vote (not one vote per competing unit).

Voting time!

.....

On the day of the WGUK Championships each WGUK member organisation (not each unit but each organisation) will be asked to vote using the following procedure:

* The Ballot Box and Voting Paper will be situated at the Check In desk

* The Ballot Box will be available until the last Guard organisation registers for Championships

* The person registering the organisation will, by default, be accepted as the unit's nominee to complete the ballot form.

* Votes not cast by the end of registration will not be counted.

To clarify and confirm the election procedure:

Each member organisation will have one vote available for Chair, one vote available for Deputy Chair and **up to 3** votes available for Board members. Your organisation can decide how many of these votes you decide to use. For example, you might decide to vote for the Chair, not vote for the Deputy and vote for up to 2 out of the 3 Board Member nominations. The most votes you can cast are one for Chair, one for Deputy and 3 for Board members. At the opposite extreme, you could decide to vote for no-one or any combination in-between.

1) To be elected as Chair the person has to received 50% or more of the vote. If less than 50% then they are not elected

2) To be elected as Deputy Chair the person has to received 50% or more of the vote. If less than 50% then they are not elected

3) To be elected as a Board member the person has to received 50% or more of the vote. If less than 50% then they are not elected.

Judges Co-Ordinator / Co-opted

.....

- Stage 1 Judges vote for their Judges Co-Ordinator at WGUK Championships
- Stage 2 The Judges Co-Ordinator (NAME) has been elected by the 2025 Judges to be their Co-Ordinator for the 2026 season but this needs to be approved by the Board.

Co-Opted

 (NAME) is co-opted onto the Board to represent xxxx, but this needs to be approved by the Board.

- Spintastic WGUK Board meet in person; support event sessions, operational supervision, network with the membership / attendees

- Bimonthly / Monthly virtual meetings Update, review & plan.
- Arrange pre-show managers meetings (Friday night)
